



DeKalb Tax Commissioner Irvin J. Johnson announces the availability of 2 self-service tag renewal kiosks which are located in the following Kroger Stores:
[2875 North Decatur Road, Decatur, GA 30033](#) and [3559 Chamblee Tucker Road, Atlanta, GA 30341](#)

Customers can now use these Kroger located kiosks before or after our work hours, on weekends, holidays and therefore avoid peak time visits during our regular office hours of 8 am to 4:30 pm, Monday through Friday. Currently, both of these stores are open 24 hours a day, 7 days a week. The kiosks may be recognized by their key lime green color and the **Georgia MVD Self-Service** logo. You also may ask Kroger store personnel to point them out to you. In order to use these kiosks the customer must meet all the necessary criteria to complete their tag renewal.

1. Live in a county with the kiosk system
2. Have a valid Georgia driver's license or have your renewal notice sent to you by mail
3. Know your tag number or have your correct address on renewal notice
4. Have valid proof of insurance in the Georgia Database on file at the time of renewal
5. Have a valid passing emission (if required) inspection record on file at the time of renewal
6. Pay all registration fees, taxes and the convenience fee by debit or credit card

Customers who utilize these kiosks can complete their transaction(s) in a few minutes and will be charged a convenience fee of **\$ 3.00** in addition to the cost of their tag renewal. These kiosks will process debit and credit cards with the associated transaction fee but they do not handle cash at this time. Customers may process up to **10** vehicle registrations per transaction at these kiosks.

This service enhancement is possible due to our strong and on-going partnership with the Department of Revenue and Intellectual Technology, Inc. This type of self-service tag renewal is already available at our Memorial Drive office. This further extends our capability and commitment to serve our customers by utilizing the most cost effective technology. This kiosk option helps to prevent requests for expensive capital outlay for building construction, additional staffing, infrastructure support, added lease or rental cost, supporting maintenance, and security personnel expenditures that would otherwise add to the taxpayer's burden. Please take advantage of this new service offered by your Tax Commissioner's Office. We thank you for allowing us to serve you!

For those customers who prefer to visit one of our three **(3) locations, (4380 Memorial Drive, 1358 Dresden Drive, or 2801 Candler Road inside South DeKalb Mall)** or use the internet or phone payment system we welcome you. Please note that peak office times are usually Mondays and Fridays along with the day after a holiday and daily lunch periods. These are the times you may want to consider or plan to use the Kroger kiosks for your convenience.
